

This document is only relevant to LaSPACE 2023-2024 subawards. Funding for 2023-2024 projects is for the entire proposed award amount, but all PoPs are truncated to 5/31/24 because the NASA parent award is set to close on 6/10/24. We anticipate a fifth-year extension to our parent award and if that is the case, you MAY be eligible to request a No Cost Extension (NCE). Review the tables below for updated eligibility, end date options, NCE request requirements, and final reporting deadlines. No additional funding will be available.

If eligible, you will need to submit a formal NCE request to LaSPACE Management (laspace@lsu.edu) no later than April 15, 2024 and no earlier than March 1, 2024. PIs who fail to submit an NCE request by the 15th of April will have their awards automatically close on May 31, 2024. If you can complete your objectives by May 31, 2024, we suggest you allow your project to close as scheduled. Final Reports are due 30 days after the end date.
